RE: SALIM'S CANDIDATURE FOR THE PRESIDENCY OF THE 34TH REGULAR SESSION OF THE U.N. GENE-RAL ASSEMBLY - 1979

Please refer to our discussion last week prior to your departure from New York.

As agreed, it is most preferable that our candidature be presented as soon as possible to our African colleagues. Accordingly, the date of Monday, August 15, 1977 would be appropriate. Necessary action should be taken simultaneously in Dar es Salaam, New York, and Addis Ababa. I am enclosing herewith the kind of format of the notes to be distributed:

> 1. Appendix A is the note which this Mission will send to the Executive Secretariat of the Organization of African Unity.

2. Appendix B is a note /whose style can be modified as appropriate7 from the Ministry to all the African Missions accredited to Tanzania. It is however important that each Mission be addressed separately.

3. Appendix C is a note from Tanzanrep Addis Ababa to the Administrative General Secretariat of the OAU. Ambassador Rupia would of course use the format and style which is in normal usage in Addis Ababa.

I am also enclosing copies of my curriculum vitae.

The important thing to emphasize is that all these notes should be sent out on Monday, August 15, 1977.

The purpose of sending the note at this early stage is to register formally our candidature. From previous experiences, it would be to the African Group and subsequently, the OAU Summit to endorse the same. This can be done either at the Khartoum Summit or at the Monrovia Summit. Khartoum would be preferable so as to finalize on the subject but discretion is needed. It is not necessary to force a decision at that juncture.

Having formally submitted our candidature, there will eventually be a need for a follow-up campaign. But at this early stage, an aggressive campaign is unwarranted. The important aspect of the present campaign should be on information i.e. to ensure that all African States are aware of our candidature. In this respect, I would recommend that all Tanzanreps be apprised prior to the formal launching of the candidature i.e. prior to August 15, but should be specifically requested not to discuss the subject until the official notes have gone out.
